## Online safety continued

### Barnardo's report – Exploring AI with children and young people

**Barnardo's has published a new report which sheds light on children's understanding of artificial intelligence (AI) and highlights critical concerns about their online experiences.**

The charity conducted focus groups and surveys with over 500 children and young people from primary and secondary schools, alongside gathering insights from parents and teachers. The report underscores several key issues raised by children, including:

- **Malicious use of AI** – worries about AI being misused for harmful purposes.
- **Privacy concerns** – fears regarding data security and how personal information is managed online.
- **Fear of AI 'taking over'** – apprehensions about AI dominating or impacting their futures negatively.

The findings reveal a disparity in AI understanding across age groups, pointing to a need for better education on the topic. Barnardo's has urged the Government to integrate practical AI lessons into the school curriculum. These lessons aim to raise awareness and equip children and young people with the tools to navigate potential online risks safely and responsibly.

This initiative aligns with broader goals of ensuring digital literacy and safeguarding children in an increasingly AI-driven world.

## Research reports



### Youth violence research

**The Youth Endowment Fund has produced four in-depth reports, with a fifth coming later this year, on the subject of youth violence.**

During the last 12 months, 20% of teenagers told the Youth Endowment Fund that they've been a victim of violence, with over half of incidents leading to an injury. These acts of violence have affected almost half a million young people, with many being attacked repeatedly during that time.

The research reports aim to find out what is driving these tragic incidents by looking at who suffers from violence, the role of social media, the differences experienced between boys and girls, and young people's views on the police.

### County Lines: Strategic Threat Report

The National Police Chiefs' Council (NPCC) and the National County Lines Coordination Centre (NCLCC) have published their Strategic Threat Report about county lines. The report is based on data from April 2023 to March 2024.

#### What is county lines?

The National Crime Agency advises that county lines is where illegal drugs are transported from one area to another, often across police and local authority boundaries (although not exclusively), usually by children or vulnerable people who are coerced into it by gangs. The 'county line' is the mobile phone line used to take the orders of drugs. Importing areas (areas where the drugs are taken to) are reporting increased levels of violence and weapons-related crimes as a result of this trend.'



#### What does the Strategic Threat Report cover?

##### Organised crime groups (OCGs)

- 1,447 OCGs operate county lines, mostly supplying crack cocaine and heroin.
- The main hubs are London, Birmingham, Liverpool and Manchester.
- There has been an increase in localised drug lines, with shorter travel distances for runners.

##### Child exploitation

- Exploited children are mostly boys (93%) aged 15 - 17 (80%); although under-14s (20%) can be involved too.
- Recruitment takes place via social media, which is used to groom children and young people with promises of gifts or money. The result can often be that children are then controlled via debt bondage.
- The main risks are violence, abuse and the use of children for laundering crime proceeds.

##### Indicators of vulnerability

- Children and young people missing from home or care (61% from home, 16% from care).
- Risk factors, such as poverty, family substance misuse, mental health issues, care system involvement and school exclusion.

##### Drug operations

- Drug running, which is a high-risk role with violent conflicts over territory.
- Cuckooing – where gangs take over vulnerable adults' homes for crime and drug sales.

##### Support and partnerships

- The report describes collaboration from police with groups like Catch22, SafeCall and Barnardo's to protect exploited children and young people.
- The report highlights the evolving tactics of county lines and the importance of disrupting these operations in order to safeguard children and young people.

## Staff conduct and safeguarding expectations

### Our Code of Conduct – physical contact and proximity guidance

We operate a no contact policy for supply staff with students, which should always be adhered to, apart from in the following circumstances:

- If a student **is at risk of harming** themselves or others.
- Where you are **providing personal care** as part of your agreed job role. You should carry out the task with sensitivity and respect. Ensure another appropriate adult is in the vicinity and is aware of the task to be undertaken.
- Supply staff who are **Team Teach trained** (please provide your consultant with your proof of qualification if you have not already done so).
- Supply staff who are **first aid trained** and are in a situation where first aid is required (please provide your consultant with current proof of qualification if you have not already done so).



If physical contact is necessary, always be mindful that physical contact and/or close physical proximity with a child, young person or vulnerable adult may be misinterpreted and may leave you open to scrutiny.

Usually, you should never be on your own with a child. If you cannot avoid this, make sure you keep the classroom door open and do not block any exits.

When working with students who have an Education, Health and Care Plan (EHCP), ensure you have a comprehensive understanding of their individual needs. This includes considerations such as their sensory, health or social, emotional and mental health (SEMH) needs, particularly concerning physical contact.

## Working Together to Safeguard Children guidance

**Working Together to Safeguard Children is a statutory guidance document, which sets out the framework for safeguarding and promoting the welfare of children and young people.** It outlines the roles, responsibilities and collaborative approach required from all organisations and individuals working with children and families. This includes local authorities, health services, police, schools and voluntary organisations. It emphasises the importance of a child-centred approach, ensuring that safeguarding efforts prioritise the needs, welfare and rights of children and young people. It also establishes clear expectations for information sharing, multi-agency collaboration and decision-making processes.

**The document highlights critical areas such as early intervention, child protection procedures, and the roles of Local Safeguarding Children Partnerships (LSCPs).** It is periodically updated to reflect legislative and policy changes and serves as a cornerstone of our safeguarding framework, aiming to protect children and young people from harm and to support their development in safe and nurturing environments.
